Waiver

The undersigned acknowledges that he/she has been notified by the Parade Committee that insurance is the responsibility of the participant with participation in said parade. The undersigned also acknowledges that he/she assumes all risks involved in connection with its participation in said parade. The undersigned agrees to waive any and all claims of rights of action it may have against the Downtown Cambridge Businesses, City of Cambridge, Guernsey County Commissioners, Cambridge Main Street, the Village of New Concord, Muskingum County Commissioners and the Parade Committee or its representatives for damages incurred, as a result of its involvement in said parade. The undersigned also agrees that they have read the Parade guidelines and will fully comply with them.

RULES FOR PARTICIPANTS

1. Only pre-registered entries may participate in the parade. Pertinent line up information will be emailed to participants and it is the responsibility of the entry to inform their participants of that information.
2. **This is an approximately 9 mile long parade. Please ensure your entry is in good working order and has plenty of fuel for the duration of the parade.**
3. **NO CANDY TO BE DISTRIBUTED DURING PARADE**
4. Do not distribute promotional items during parade unless you provide someone to pickup items from sidewalks after parade. We do not have volunteers to pickup the trash left.
5. Walking entries that wish to participate in both the Cambridge and New Concord portions of the parade are responsible for transportation from one location to the other. A staging area for those vehicles will be provided.
6. All units should be clean and decorated with a space or appropriate theme. Music is encouraged but not required.
7. Float is considered a separate unit pulled by vehicle.
8. Each business or organization is limited to two vehicles per business/organization. (First responders are excluded from this)
9. Liability insurance is the responsibility of each individual unit. A hold harmless waiver form must be signed by each unit holding Cambridge Main Street, City of Cambridge, Guernsey County Commissioners, the Village of New Concord, Muskingum County Commissioners and the parade committee harmless of liability.
10. Maintain a safe distance from the unit in front of you, but try to prevent gaps. We will have parade committee volunteers in streets directing the flow.
11. We reserve the right to reject entries that may be considered unsafe, harmful or potentially offensive to our spectators.
12. Please remove any trash accumulated during final preparations from the staging area.
13. Horse entries are responsible for exhaust cleanup.
14. As the applicant for participation, it is your responsibility to ensure that every member of your organization or group be aware of these rules.
15. **ANY VIOLATION WILL RESULT IN IMMEDIATE ELIMINATION FROM THIS AND FUTURE PARADES.**
